

# MICHAEL GOODWIN'S HABEAS CORPUS PROSPECTUS

1. The Michael Goodwin case has many similarities to the Steven Avery case. Both were falsely convicted. Neither received a fair and impartial hearing. Both trials presented no evidence connecting them to the murders.
2. Paramount to the jury's belief that Michael Goodwin had something to do with the murders any way was the sighting of a man inside a station wagon scoping out the neighborhood with binoculars days before the murder. Two eyewitnesses identified that man as Michael Goodwin (with another unidentified black male inside the station wagon.) The subsequent police lineup was tainted, based on both suggestiveness and reliability.
3. A private investigation by a licensed Certified Fraud Examiner showed that the eyewitnesses lied about the distance that they were from the man, as they could not possibly have identified anyone for the few seconds they said they saw him at the greater distance that they were actually viewing him (and from 13 years prior.)
4. A subsequent private investigation by the same licensed Certified Fraud Examiner determined that the two men in the station wagon were in fact DEA agents identifying license plate numbers of vehicles leaving the Thompson residence.
5. Another investigation by the same investigator reveals that the DEA had a case file open on Mickey Thompson many years prior to the murders. The San Diego Police Department also declared that the prior murder of Scott Campbell, Mickey Thompson's nephew, murdered in a drug deal, was related to the murder of Mickey Thompson.
6. Declarations confirming the DEA's involvement in the drug investigation of Mickey Thompson have recently been obtained. The declarations also confirm the make, model and color of the station wagon as being a DEA surveillance vehicle and that it was used in the neighborhood surveillance of the Mickey Thompson home before the murders.
7. Another investigation by the same licensed Certified Fraud Examiner shows that there were many people who wanted to harm Mickey Thompson. Chief among those was the Cali Cartel and the Vagos motorcycle gang. Evidence shows this was a drug murder.
8. A book documenting this ten year investigation will be published by a major publisher and released in April, 2016. Movie and TV series rights are in negotiations.
9. Newly found evidence proves that Michael Goodwin had placed into a bankruptcy trust account the funds necessary to pay Mickey Thompson for the money owed him. The bankruptcy trustee was the only one who could legally pay Mickey Thompson the money. This negates the prosecution's allegation that Goodwin had a motive to kill both Mickey and Trudy Thompson (to avoid payment.)
10. Michael Goodwin has been working hard to gather the evidence necessary for his habeas, but is still being thwarted by the trial court's refusal to provide him with his trial exhibits, discovery, transcripts of critical hearings, suppressed Brady materials and trial witness statements.
11. The review of the Michael Goodwin case has uncovered over 1,000 perjuries, lies, frauds, errors, crimes, Brady materials, and other suppressions of evidence.
12. There are at least four major civil suits to follow Michael Goodwin's exoneration, worth multiple millions of dollars.
