### ATTACHMENT TO APPLICATION FOR EXTENSION OF TIME

Re: People v. Michael Frank Goodwin Appeal No. B197574 (Los Angeles Superior Court No. GA052683)

This appeal, which follows appellant's convictions for two counts of special circumstance murder, presents 17 issues (with numerous subparts) along with a cumulative error claim, based on a record totaling approximately 5,500 pages of reporter's transcripts. Appellant's oversized opening brief is 510 pages long. It appears that appellant received approximately eight 30-day extensions of time, along with a 321-day extension and a 15-day extension to file the opening brief. Briefing was also stayed numerous times for record augmentation.

My obligations in other previously assigned matters prevented me from completing the respondent's brief before the current deadline. During the past 30 days, I filed the respondent's brief in *People v. McGraw*, B236410, which involved five issues and 934 pages of reporter's transcripts, and *People v. Vasquez*, B242760, which involved thee issues and 1,265 pages of reporter's transcripts. I also completed the respondent's brief in *People v. Martinez*, B240574, and I am in the process of completing the brief in *People v. Quiroz*, B241039. After that, I have three previously assigned matters: (1) a response to the habeas corpus petition in *Archibald v. Spearman*, CV 12-9300 ODW, pending in the United States District Court, Central District of California; (2) the answer brief in *Kasper v. Cal. Dept. of Corrections & Rehabilitation, et al.*, 10-56527, pending in the Ninth Circuit Court of Appeals; and (3) various issues in a motion to dismiss the Second Amended Habeas Corpus Petition in the capital matter of *Curtis Fauber v. Kevin Chappell, Warden*, CV 95-6601-GW, pending in the United States District Court.

For the foregoing reasons, I respectfully request a 60-day extension of time to file the respondent's brief in this case.
